To live in Albania you have to:

Be a student;

Work in a company that is registered in Albania;

Establish your own one-person or shareholder company with partners;

Family reunion;

Work in religious institutions.



As a Student:

- **There are three applicable packages:**
 - *General Information Package;*
 - *School/Language Course Information and Introduction Package;*
 - *Information and Tour Package;*

As an Employee:

- The company that is registered in Albania and has accepted you as employee, will prepare and inform you about the visas, work permit and residence permit. The company may apply for you or can contract another service provider company for above applications.

As a Company Owner/Self employed:

- You choose the type/sector of business you want to do;
- You choose the company name;
- You choose if you will do import/export;
- You can be the owner of one-person company;
- You can be the stockholder of the shareholder company with partners;

As an One-Person Company Owner:

- You give us the authorization with notary to establish the company in your name;
- You have to show the valid identification document;
- **After establishing the company:**
- You can not sell your one-person company;
- The details can be changed, address, contacts, activities can be added;
- **Monthly expenses:**
- Company office rental tax;
- Self employed social insurance;
- Accountant services.

As an One-Person Company Owner with VAT (if you will do import/export):

- You give us the authorization with notary to establish the company in your name;
- You have to show the valid identification document;
- **After establishing the company:**
- You can not sell your one-person company;
- The details can be changed, address, contacts, activities can be added;
- **Monthly expenses:**
- Company office rental tax;
- Self employed social insurance;
- Accountant services.

As a Shareholder Company with Partners:

- Shareholder(s) give us the authorization with notary to establish the company in shareholder(s) name;
- Shareholder have to show the valid identification document;
- We will prepare the "Act of Incorporation" with % of each shareholder(s);
- We will prepare the "Status of Establishment of the Company";
- **After establishing the company:**
- Shareholder(s) can sell the company;
- Shareholder(s) can sell company's stock(s);
- The details can be changed, address, contacts, activities can be added;
- **Monthly expenses:**
- Company's office rental tax;
- Shareholder(s) employment social insurance tax;
- Accountant services.

As a Family Reunion:

- One member of your family shall be living in Albania, and he/she shall have valid residence permit. This person may prepare invitation and may apply for his/her family members to obtain the residence permit .

As an Employee in Religious Institutions:

- The religious institutions administrate will prepare the invitation letter and all necessary documents for its member personnel. They will apply for resident permit via embassy or other related institutions.
